

Structured Screening for Developmental Delays and Autism Spectrum Disorders (ASDs)



Developmental surveillance and screening for developmental delays and ASDs should be conducted at intervals which meet the standards of medical practice as established by the recognized medical organizations involved in child health care, primarily the American Academy of Pediatrics (AAP).

According to the AAP, structured screening for developmental delays and ASDs includes the use of standardized, scientifically validated tools to aid in early identification and treatment. Structured screening focuses on assessing specific developmental milestones in language and cognitive abilities, fine and gross motor skills, and social interactions as well as signs and symptoms of ASDs.

Providers should conduct structured screening outside of recommended periodicities when medically necessary.

When a child is identified as needing further evaluation through screening, the provider should refer them to the **Early Intervention Birth to Three Program** for ages 3 and younger. To make a referral, providers must complete the WV Birth to Three Referral Form at hho.fyi/wv-b23 and submit it to the child's county of residence or call **1-866-321-4728**.

Billing

All EPSDT screening services must be reported with age-appropriate evaluation and management code along with the EP modifier.

Service	CPT Code
1 month to 11 months EPSDT visit	99381/99391
12 months to 4 years EPSDT visit	99382/99392
Developmental Screening	96110
Autism Screening	96110 U1

When the validated screening tool identifies the child as needing further evaluation, a diagnostic evaluation should be performed by the provider or through a referral to an appropriate specialist or the early intervention program.
